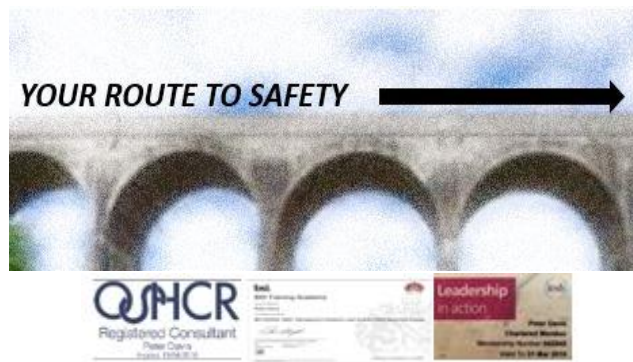

The retained competent person service allows you to plan financially for your health and safety needs, removing the need for expensive one-off payments to have your systems audited. Payments are spread throughout the year and paid via monthly standing order or monthly invoicing.
